After consideration of proof of record and the terms of the Agreement of Settlement filed herein on 4/22/98, whereby the claimant agreed to settle all rights which the claimant has against the named employer because of the employer's alleged violation of specific safety requirement for the sum of \$8,750.00, the Staff Hearing Officer finds that said Agreement, signed by both claimant and employer, is fair and equitable and hereby approves and ratifies the said Agreement and incorporates said Agreement in this order by reference as if fully rewritten herein, contingent upon the claimant accepting the agreed sum in full and complete satisfaction of all past, present and future rights which the claimant has or may have in the future arising out of the employer's alleged violation of a specific safety requirement.

NOTHING IN THIS ORDER SHALL BE CONSTRUED TO AFFECT ANY RIGHT WHICH THE CLAIMANT HAS TO THE PAYMENT OF REGULAR COMPENSATION.

In carrying out the terms of the Settlement Agreement, the employer shall pay the agreed sum to the claimant upon the claimant signing a receipt for said amount and signing a release that said amount is received in full and complete satisfaction of all past, present and future rights which the claimant has or may have in the future arising out of the employer's alleged violation of specific safety requirement. Upon completion, said receipt and release shall be filed with the Industrial Commission.
